MEETING MINUTES Meeting Date: April 29, 2021

President Nicholson opened the meeting.

1. Opening Statements:

- a. <u>Minutes of the March meeting have been properly approved and posted</u> to the RCRVR Golf Club website.
- 2. Golf Course Open Items—Juan: None.
- 3. Greens Keeper Report and Golf Course New Business—Juan:
 - a. We have been "pre-approved" for a coot relocation permit for 2022.
 - b. On hole #8 the turf will be built up between the green and the lake.
 - c. Plans to relocate the red tees on #4 have been cancelled.
 - d. Mowers will be adjusted "one notch up" to <u>cut fairway grass longer</u>; outcome will be assessed and discussed at next month's meeting.
 - e. All greens will be converted to bentgrass.

4. Treasurer Report:

a. April 29, 2021, <u>cash on hand</u>—\$427.00 and <u>cash in the bank</u>--\$3,050.64. The <u>Hole-in-One Pool</u> is at \$205.00.

5. Committee Open Items:

a. Practice Net(s) location has been tabled—Jeff/Juan.

6. <u>Tournament Chair Report:</u>

- a. Starting this month, we will <u>resume "pick your own teams of 4" on even Saturdays and "draw for teams of 4—pairs are allowed" on odd Saturdays.</u>
- b. If Covid-19 restrictions continue to lighten, we expect to resume organized golf club activities "as usual" this Fall.
- c. <u>The tournament schedule for 2021/2022 season has been posted</u> to the golf bulletin board and on our website.
- 7. Social Director Report: Due to Covid-19, we are allowing limited social activities after golf tournaments—no snacks, only self-contained drinks (sodas and beer), and a maximum number of 24 people allowed in SCH (per HOA). As Covid-19 situation improves, we will relax social time restrictions.

8. Handicap/Rules Chair Report:

- a. The monthly calculation, printing, and posting of the handicap report has resumed and will occur the last day of each month.
- b. Golfers can once again access the golf computer so announcements at weekly tournaments (Mondays, Wednesdays, Thursdays, Saturdays) will be made to:
 - i. remind golfers how to correctly tabulate and post scores and
 - ii. caution golfers to NEVER take any action at the golf computer (delete, search, etc.) other than to post scores—we could lose EVERYTHING.

9. Other/New Business (including audience input):

- a. The MCH has been reserved for 2022 Club Championship setup and dinner (April 1, 2022, and April 3, 2022, respectively.
- b. A meeting room in the MCH has been reserved for May, September thru December, 2021, and January thru May, 2022, Golf Committee Meetings which are scheduled at 3:00 pm on the last Thursday of each of those months.
